Indemnity Waiver and Release of Liability

1. Acknowledgment of Risks

I, the undersigned, understand that participation in mobile laser tag activities involves inherent risks, including but not limited to:

- Physical injuries resulting from falls, collisions, or contact with laser tag equipment;
- Injuries resulting from the misuse or malfunction of laser tag equipment;
- Injuries occurring during the setup, use, or dismantling of laser tag equipment;
- Exposure to environmental hazards or uneven terrain at outdoor locations.

I acknowledge that despite the reasonable safety measures taken by Sydney Laser Tag Hire, the possibility of injury cannot be entirely eliminated. I voluntarily choose to participate or allow my children to participate in these activities, fully understanding the risks involved.

2. Release and Waiver of Liability

I hereby release, waive, discharge, and hold harmless Tia-jane Freeman T/as Sydney Laser Tag Hire, its employees, agents, contractors, and any affiliated persons or organisations from any and all liability, claims, demands, actions, or causes of action arising from injury, loss, or damage to myself, my children, or my property while participating in laser tag activities or while on the premises where the activities take place.

This release includes but is not limited to liability arising from:

- Negligence on the part of Sydney Laser Tag Hire or its representatives;
- Equipment malfunction or failure;
- Accidents occurring in or around the laser tag activity zone;
- Any claims for medical expenses or other damages that may result from participation.

3. Supervision of Minors

For participants under the age of 18, the following terms apply:

- I, as the supervising adult, assume full responsibility for the safety, supervision, and behavior of the children listed in this waiver.
- I certify that I have the legal authority to sign this waiver on behalf of the minors under my care and that I fully understand and accept the risks associated with their participation.

4. Assumption of Responsibility

I agree to:

- Follow all safety guidelines and instructions provided by Sydney Laser Tag Hire staff;
- Ensure that all participants under my supervision also adhere to the safety rules;
- Assume full responsibility for any personal injuries, property damage, or other liabilities that may occur during participation in laser tag
 activities.

5. Medical Condition and Fitness

I certify that I, or the children under my care, are in good physical condition and have no known medical conditions that would prevent safe participation in laser tag activities. I acknowledge that it is my responsibility to disclose any relevant medical conditions prior to participation.

6. Governing Law

This waiver shall be governed and interpreted under the laws of New South Wales (NSW), Australia. Any legal action arising from participation in laser tag activities shall be brought in the appropriate jurisdiction in NSW.
